Data Needed	The information necessary for this indicator can be found in national laws, policies and public documents relevant to regulations surrounding private and public investments as well as those explicitly addressing requirements of Free Prior and Informed Consent (FPIC).	
How to Implement	<ul style="list-style-type: none"> • Questions in indicator 9B.2 should be answered by a chosen representative of the stakeholder group that is implementing the indicator. <ul style="list-style-type: none"> ◦ No specific requirements apply, though knowledge of the laws and policies regarding public and private investment, as well as requirements of FPIC, will be fundamental. • Indicator 9B.2 has only one section, which we refer to as a “block.” • In Section 2 you will find one block (Block 1) that includes a number of questions that should be answered according to the scoring system outlined below. The resulting number will be the “Block 1 Score” or B1, and it will be used in Section 3 to obtain the final score for Indicator 9B.2. 	
How to Score	Block 1:	For each question, assign the corresponding score (0-3) from the rubric provided. Provide justifications and references and, at the end of Block 1, sum the scores from these three questions to derive B1.
	Final Score	Divide B1 by total possible points (18) and multiply by 100 to derive the Final Score for Indicator 9B.2 (0-100).
